2026 - 2027 FINANCIAL POLICIES

Crawford Adventist Academy (CAA) is partially subsidized by the Ontario Conference of the Seventh-day Adventist Church. These subsidies assist in making our standard fees considerably lower than most independent schools. These fees are further reduced for members of Constituent Adventist churches who also subsidize our schools.

BILLING PROCEDURES

CAA billing procedures are as follows:

- Non-Refundable Tuition (Space Reservation) deposit of one month tuition on August 1st.
- Monthly tuition fee on the 1st of each month from September to May. (All accounts are expected to be current).
- Parents are expected to make Pre-Authorized Payment arrangements. Other modes of payments are cash, cheque, bank payment, e-transfer, major credit cards, debit card and online through our website..
- Delinquent accounts or NSF cheques will affect all family members billed in the same account. They are required to pay by cash, bank, or e-transfer .

PAYMENT OPTIONS

Pay the Tuition Deposit on the 1st of August and choose one of the following options suitable for you.

1. **Early Payment Option:** Pay remaining full year's tuition in advance before the first day of school with a 5% discount if paid by cash, cheque and debit card and 3% for credit card and online. Processing fee will also be waived.
2. **Quarterly Payment Option:** Pay remaining nine months tuition in three quarters on or before the last working day of August, November and February with a discount of 2% for cash, cheque and debit card payments and 1% for credit card and online payments.
3. **Monthly Payment Option:** Remaining 9 months tuition by the 1st of each month from September to May.

REGISTRATION:

All returning students are expected to register, obtain financial clearance and admission card on or before the last registration date in August. Late fee of \$50.00 and Processing Fee of \$50.00 will apply to those who register after the Registration date in August.

TUITION FEE

Tuition fee includes workbooks, textbooks, local field trips, yearbook, agenda, graduation, essential classroom supplies for JK to Grade 6 and limited photocopies for all students. It also includes Grade 12 College day trips.

REFUNDS

Leaving students may submit formal written request addressed to the Business Office for unused tuition fee. Refunds will not be issued after May 1st. Registration, Processing Fee and Tuition Deposit are non-refundable.

FINANCIAL AGREEMENT

All parents who enroll their child/ren are responsible for payment of tuition and other fees and are required to sign a "Financial Agreement" form during registration. The private information you provide will be secured.

CHURCH MEMBERSHIP CONFIRMATION

New Students – it is mandatory for TADSB Constituent Church members to obtain and submit Church Membership Confirmation in writing from the church pastor or clerk for Church Member Discount.

LATE PAYMENT

On the 16th of each month a late fee of 2% will be applied to the account that has an outstanding balance. Students with unpaid accounts will not be permitted to take semester exams, receive grades or transcripts and may not participate in graduation and any school sponsored activities.

TERMINATION OF EDUCATIONAL SERVICE:

All accounts must have a zero balance prior to registration. All student accounts will be reviewed on November 15th (1st Term) and March 15th (2nd Term) in the academic year. If your account is not up to date on these dates, CAA will terminate your educational service effective November 30 (1st Term) and March 31 (2nd Term).

CAA will not be responsible for students who are sent to school once educational services have been terminated and the responsible person informed by the school. Students will not be permitted to attend classes and will be requested to remain in the Administrative office until picked up by a parent/guardian. Failure to pick up your student will result in notification of the authorities. All student accounts must be in good standing to be offered re-admission.

TEXTBOOKS AND CHROMEBOOKS

All textbooks and Chromebooks assigned to students must be returned to the teacher on the last working day of the school. Late fee of \$2.00 per book per week and \$25.00 p.m. for Chromebook will be charged for late return. Replacement cost for damaged or lost book will be charged.

TRANSPORTATION

Students transportation arrangements are in place for each campus. Please contact the Principals' Office for more details and for registration Also refer to the back page for cost.

DISCOUNTS

INTERNATIONAL STUDENTS

Visa Student - In addition to providing the appropriate documents, a visa student is required to pay full year tuition fee in advance.

Children of Adventist church members may be offered a discount on tuition fee provided proof of church membership is submitted.

Visiting Student - In addition to providing the appropriate documents a visiting student is required to pay non-discounted rate of tuition. An acceptable pre-authorized plan should be submitted to the Business Office in advance for monthly tuition.

FINANCIAL AID

Each year a number of scholarships are available to deserving new/returning students. .

1. Financial Assistance Program: For JK to Grade 12.
2. Three - Way Matching Fund: For Grade 9 to 12
3. Alumni Discount - Choose one if eligible for other.

Contact the Business Office for details and application forms before June 30th. Completed forms must be submitted to the Business Office with a copy of recent Tax Assessment Notice received from Canada Revenue Agency before July 1st. Parent of new student may submit Financial Assistance application within two weeks of acceptance in to the school.

FINANCIAL CLEARENCE

All parent choose monthly or quarterly payment option must complete specific "Financial Arrangement Form". Account should be in good standing with no outstanding balance and pay the tuition deposit for Financial Clearance. Parents who pays full year fee in advance are exempted.

MUSIC INSTRUMENT RENTAL

All students taking instrumental music or performing in an ensemble must have an instrument for classes and rehearsals. Students may provide their own instrument or rent one through the school's rental program. Contact Band Director for details.

TAX RECEIPT

Our schools provide a child care expense receipt and religious donation receipt. However, the school strongly recommends that you seek tax advice from your financial advisor before making a claim.

⇒ **Child Care Expense** - Under current legislation, students under 12 years old may be eligible for a child care expense receipt of approximately 20%.

⇒ **Religious Donation Receipt** - In consideration of our status as a Christian educational institution, we provide a religious donation receipt as per Canada Customs and Revenue Agency Circular No. 75-23 Dated September 29, 1975 based on variable percentage of fees. Tax receipts will be mailed before the last day of February.

⇒ **T4A** will be issued as per Canada Revenue Agency Regulation for Financial Assistance, Special Discount, Scholarships and all other discounts. These receipts will be issued on a school year basis and mailed by the last day of February. Student SIN will be required

CHILD CARE
